**NOTICE** 

This Department has decided to organise an one day EXPO on 24.11.2019 [Sunday] at Bhubaneswar for demonstration of various equipments/ machineries used in the processing of wet waste & dry waste in Micro Composting Centres [MCC] of 1 to 5 TPD capacity and Material Recovery Facilities [MRF] respectively, which includes Organic Waste Shredder with conveyor belt, Compost Sieving machine, Napkin Incinerator, Baling Unit (For baling of plastic waste up to 20-25 Kg bales), Battery Operated Vehicle (Tricycle, 4-wheeler-Low duty) to negotiate narrow lanes/streets for short distance transportation of segregated waste etc.

Ready made Stalls shall be available for display and demonstration of the equipment by the Manufacturers / Authorised Traders to the officials viz. the Commissioners/Executive Officers and the Municipal Engineers of the Urban Local Bodies of the State.

The Manufacturers / Authorised Traders will also have an opportunity to make a Power Point presentation before the aforesaid officials to provide more details / key features, support and services mechanism and other relevant information relating to marketing their products.

The Manufacturers / Authorised Traders are also required to enrol themselves in the GeM Portal to facilitate procurement by the ULBs if the products are found suitable for use in the MCC and MRF. If not already enrolled, they may enrol immediately (preferably before the EXPO) and attend the EXPO.

PTO

There will be twenty stalls *in toto* [Each stall of about 400 square feet size] for which the organiser reserves the right to select twenty suitable Manufacturers / Authorised Traders from the nominations received within the stipulated date to participate in the EXPO.
