No.17718–HUD-TP(DA)-PROJ-15/2017/HUD.— Whereas, a Note of Cooperation has been signed between Housing & Urban Development Department, Revenue & Disaster Management Department and Gesellschaft fur Internationale Zusammenarbeit (GIZ) engaged by the Department of Land Resource of Ministry of Rural Development, Government of India with an objective to strengthen the overall culture of democratic and integrated spatial land use planning at all levels by enhancing the capacities of state planning institutions in applying standardised land use planning and management instruments,

And whereas, Housing & Urban Development Department through the Directorate of Town Planning, Odisha, Bhubaneswar, Revenue & Disaster Management Department & GIZ have agreed to cooperate for achieving the following objectives of the Land Use Planning and Management Project.

- Formulation of State Land Use Policy.
- Development and application of Land Use Planning Standard/Instruments.
- Human Capacity Development.
- Organisational/ Institutional Development.

Therefore, Housing & Urban Development Department do hereby constitute the State Level Steering Committee comprising the following members to steer, monitor, evaluate and facilitate the implementation of the above project.

The terms and reference of the State Level Steering Committee will be as follows:—

- (a) To facilitate, evaluate, monitor and steer implementation of project on Land Use Planning and Management in the State of Odisha to mitigate potential conflicts between competing land use types that are of State concern.
- (b) Understanding the land use planning system and case examples from other States in India, Germany and other relevant Countries as presented by experts from Germany/GIZ and exploring their relevance to Odisha.
- (c) Review of baseline situation analysis applicable at the State level.
- (d) Review of progress of demonstration projects in the two selected areas in Odisha, that will be undertaken at District as well as local level (urban/ peri-urban area) and help provide platform for other District to replicate.
- (e) Review draft policy preparation on land use planning and management for the State.
- (f) To facilitate and guide dialogue, information exchange, knowledge exchange on land use planning among various stakeholders at State level through workshop, lectures/ presentations from subject experts/ institutions, brainstorming sessions etc. with a view to ensure optimal socio-economic development along with enhancement of prospect of food security, mitigating conflicts between competing land uses and introducing a systematic land use planning and management process.
- (g) The State Level Steering Committee shall meet at least twice a year for reviewing the progress of the projects.
