HUD-TP-POLICY-0001-2015 No. 7191 /HUD, Whereas under the reform agenda to facilitate and regulate the process of urban expansion, the transfer of planning function to the Urban Local Bodies of the state of Odisha under 74th Constitution Amendment Act was under active consideration of the Government for some time.

And whereas in order to carry out these reforms, the State Government desires the Urban Local Bodies should function and exercise such powers as provided under law. The State Government in exercise of the power conferred by the section 153A of the Odisha Town Planning and Improvement Trust (Amendment) Act, 2021 do hereby declare the Urban Local Bodies as Special Planning Authorities as mentioned in column (2) of the schedule below within the areas under their respective jurisdiction.
