No.19356—HUD-PROJ-SCH-0020-2021/HUD.— Government in Housing & Urban Development Department have been pleased to constitute a **State Level Technical Committee (SLTC)** headed by the Principal Secretary/ Commissioner-cum-Secretary/ Secretary, Housing & Urban Development Department, as prescribed in the Atal Mission for Rejuvenation and Urban Transformation 2.0 (AMRUT 2.0) Operational Guidelines of Ministry of Housing and Urban Affairs, Government of India, to carry out technical and financial appraisal of the Detailed Project Reports under the AMRUT 2.0 Mission Programme.
