Sealed proposals are invited by the Jaga Mission, Housing & Urban Development Department from amongst the autonomous registered non-profit civil society organizations (CSOs) to select most suitable of them for mobilization and capacity building of slum communities for upgradation, delisting and mainstreaming of slums activities under Jaga Mission.

The contract for empanelment will be valid for a period of 2 years. It may be extended based on the requirement of the Mission. The CSOs will be empaneled on Quality Based Selection (QBS) process. The CSO is to submit a technical proposal for one city or more than one depending upon their strength (Maximum for 5 cities).

Initially the work will be focused on two cities of Bhubaneswar Municipal Corporation and Cuttack Municipal Corporation, for a period of six months, which will be further extended to all Urban Local Bodies of the State, upon assessment of impact in the two cities. Further details of the services requested are provided in the various annexure enclosed with this letter. This RFP includes the following documents:

Annexure I

Instruction to bidder

1. Introduction

- 1.1. These instructions should be read in conjunction with information specific to the consulting services contained in the Covering Letter, Data Sheet and accompanying documents.
- 1.2. The Technical Proposal ONLY shall be the basis for selection of successful bidders for empanelment.
- 1.3. The Bidder shall bear all costs associated with the preparation and submission of its proposal and contract negotiation.
- 1.4. Jaga Mission is not bound to accept any proposal, and reserves the right to cancel the selection process at any time prior to award of contract without thereby incurring any liability to the bidder.
- 1.5. In no case, sub-letting / Joint venture / Consortium would be accepted.

2. Eligible Bidder

- 2.1 The invitation is open to registered non-profit Civil Society Organizations (CSO) set up by state or central governments relevant act.
- 2.2 CSOs must be registered in NGO Darpan Portal & must have UID number from NITI Ayoga.
- 2.3 CSOs must have prior experience in social mobilization, training and capacity building in rural or urban areas.
- 2.4 CSOs should have minimum experience of 7 years in social mobilization and capacity building through community driven programmes.
- 2.5 The organization should have worked with Govt/Semi Govt organization in the area of Urban poor, Community strengthening, Training, Capacity Building.
 - CSOs should have minimum 20 numbers of manpower in their payroll as on 31.03.2021. (For applying for 2cities or more (Max 5) manpower should be minimum 40) The resources should be effective in guiding people to take up various Capacity building programs. The qualification and experience for the employee (Capacity Building professional) is outlined as:
 - i. Masters in Social Work/ Masters in Arts/ Masters in Business Administration/Law.
 - ii. Minimum of 5 years of experience in Community Mobilization, Capacity Building trainings.
 - iii. Preferably with experience of working in slums.
 - iv. Strong communication and interaction skills (in local language)
- 2.6 The CSO must have undertaken project/programme at field level in any district of the state. The district authorities will be requested to share their feedback on the performance of the CSO.
- 2.7 "Average" Annual turnover of the bidder should be more than Rs 50 lakhs during last three financial years for applying for one city. Since bidder can offer maximum for 5 cities, turn over requirement to apply for more than 1 city will be average Rs. 1.00 Crore during last three financial years. The CSOs should have audited financial statement of last three years (2018-19,

2019-20, 2020-21*).

(*For 20-21 if audit is not complete provisional statement signed by CA can be considered)2.8 No Joint/Consortium bid is permitted.

3. Conflict of Interest

Conflict of interest exists in the event of: (i) conflicting assignments, typically monitoring and evaluation of the same project by the eligible Bidder; (ii) CSO who have a business or family relation with Jaga Mission directly or indirectly; and (iii) practices prohibited under the anti-corruption policy of the Government of India and Government of Odisha.

4. Disclosure

- 4.1 Bidders have an obligation to disclose any actual or potential conflict of interest. Failure to do so may lead to disqualification of the Bidder or termination of its Contract.
- 4.2 Bidders must disclose if they are or have been the subject of any proceedings (such as blacklisting) or other arrangements relating to bankruptcy, insolvency or the financial standing of the Bidder, including but not limited to appointment of any officer such as a receiver in relation to the Bidder's personal or business matters or an arrangement with creditors, or ofany other similar proceedings.
- 4.3 Bidders must disclose if they have been convicted of, or are the subject of any proceedings relating to:
 - a) a criminal offence or other serious offence involving the activities of a criminal organization, or where they have been found by any regulator orprofessional body to have committed professional misconduct;
 - b) Corruption including the offer or receipt of an inducement of any kind in relation to obtaining any contract;
 - c) Failure to fulfill any obligations in any jurisdiction relating to the paymentof taxes or social security contributions.

5. Anti-corruption Measure

- 5.1 Any effort by Bidder(s) to influence Jaga Mission in the evaluation and ranking oftechnical Proposals, and recommendation for award of Contract, may result in the rejection of the Proposal.
- 5.2 A recommendation for award of Contract shall be rejected if it is determined that the recommended Bidder has directly, or through an agent, engaged in corrupt, fraudulent, collusive, or coercive practices in competing for the contract in question. In such cases Jaga Mission shall blacklist the Bidder either indefinitely or for a stated period of time, disqualifying it from participating in any H & UD Dept. related bidding for the said period.

6. Clarification on Provisions of the RFP Document

7. Pre-Bid Conference

Besides requesting clarification through e-mail, interested bidders can also clarify their queries by participating in the pre-bid conference.

8. Language of Proposals

The Proposal and all related correspondence exchanged between the Bidder and the Client shall be written in the English language. Supporting documents and printed literature that are part of the Proposal may be in another language provided they are accompanied by an accurate translation of the relevant passages in English with self-certification for accuracy, in which case, for the purposes of interpretation of the Proposal, the translated version shall govern.

9. Cost of bidding

The Bidder shall bear all costs associated with the preparation and submission of its Proposal. Jaga Mission shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

10. Taxes

The Bidder may be subject to taxes (such as: fringe benefit tax, value added or salestax, service tax, duties, GST as applicable, etc.) on amounts payable by the Jaga Mission under the Contract, which are to be borne by the bidder.

11. Submission of Proposal

- 12.1 Proposals must be received before the deadline specified in the Data Sheet.
- 12.2 Proposals must be submitted to the address specified on the Data Sheet and delivered on or before the time specified in the Data Sheet.

12. Documents comprising the Proposal

Bidders shall submit one sealed envelope, containing the Technical Proposal for each city. The Technical Proposals will be opened at the date and time specified in the Data Sheet.

13. Proposal validity

Proposals shall remain valid for the period specified in the Data Sheet commencing with the deadline for submission of Technical Proposals as prescribed by Jaga Mission.

14. Format and Signing of Proposals

- 15.1 A single Technical Proposal (original) for each city as mentioned in the Data Sheet shall be submitted in the prescribed format attached with this RFP document at *Annexure-IV*.
- 15.2 The original Technical Proposal shall be signed by a person duly authorized to sign on behalf of the Bidder. The name and position of the

person signing the authorization must be typed or printed below the signature. All pages of the Technical Proposal shall be signed by the person signing the Proposal with date.

15.3 Any interlineations, erasures, or overwriting will not be accepted.

15. Deadline for Submission of Proposals

Jaga Mission may, at its discretion, extend the deadline for the submission of TechnicalProposal by amending the RFP, in which case all rights and obligations of the Bidders subject to the previous deadline shall thereafter be subject to the deadline as extended.

16. Late Proposals

Jaga Mission will not consider any Proposal that arrives after the deadline prescribed for submission of Proposals in the Data Sheet. Any Proposal received after the respective deadline for submission shall be declared late, rejected, and returned unopened to the Bidder.

17. Evaluation of Offers:

Bids received and found valid will be evaluated by Jaga Mission to ascertain the best evaluated bid in the interest of Jaga Mission for proposed services under this document. The Bidder should take enough care to submit all the information sought by Jaga Mission in the desired formats. The bids are liable to be rejected if information is not provided in the desired formats, however Jaga Mission reserves right to seek any clarification from any bidder if it so desires.

Technical evaluation of the bid would be carried out applying the evaluation criteriaspecified below. Each respective technical bid will be attributed a technical score as per following breakup:

18. Selection/ Empanelment:

Minimum Qualifying score for empanelment shall be 70 Marks. As per the above scoring the merit list will be prepared city wise. The resource organizations willbe selected in order of their marking. The empanelment list will be maintained and in the event of selected resource organization not willing/ able to carry out the scope of work to achieve the projected target, in such event Jaga Mission may take over the work or appoint another resource organization in the same geographical area. In the first phase work will be allocated for Bhubaneswar and Cuttack city.

In the subsequent phase based on success of the program in these cities the scheme shall be expanded to other cities. The performance of RO not found satisfactory in these cities will not be considered for other cities even though might have been empaneled under this RFP.

19. Client's Right to Accept any Proposal, and to Reject any or all Proposals

Jaga Mission reserves the right to accept or reject any Proposal, and the bidding process and reject all Proposals at any time prior to Contract award, without thereby incurring any liability to the Bidders.

20. Negotiations/Clarifications

The successful Bidder will be informed in writing of the date, place and time for negotiations/clarifications, if any. Representatives conducting negotiations on behalf of the Bidder must have written authority to negotiate and conclude a Contract.

21. Signing of Contract

- 21.1. After notification, the Client shall communicate to the successful Bidder to sign the Contract.
- 21.2. Pursuant to negotiations, the successful Bidder shall sign, date, and return the Contract, along with necessary supporting documents, to the Client.
- 21.3. All formalities of negotiation and signing of contract will be completed within seven (7) days of notification of award.

22. COMMENCEMENT, COMPLETION, MODIFICATION AND TERMINATION OF CONTRACT

- 22.1. **Effectiveness of Contract:** This Contract shall come into force and effect on the date (the "Effective Date") of the "Client's notice to the Resource Organization instructing the Agencies/Organizations to begin carrying out the Services.
- 22.2. **Termination of Contract** for Failure to Become Effective: If this Contract has not become effective within such time period after the date of the Contract signed by the Parties, client may, by not less than 30 days written notice to the Agencies/Organizations, declare this Contract to be null and void, and **forfeit the EMD**.
- 22.3. **Commencement of Services:** The Agencies/Organizations shall begin carrying out the Services not later than 7 days after the effective date.
- 22.4. **Expiration of Contract This** Contract shall expire at the end of one year from the date effective unless extended by Jaga Mission.
- 22.5. **Entire Agreement:** This Contract contains all covenants, stipulations and provisions agreed by the Parties. No agent or representative of either Party has authority to make, and the Parties shall not be bound by or be liable for, any other statement, representation, promise or agreement not set forth herein.
- 22.6. **Modifications or Variations:** Any modification or variation of the terms and

conditions of this Contract, including any modification or variation of the scope of the Services, may only be made by written agreement between the Parties.

23. Force Majeure

23.1. Definition

- For the purposes of this Contract, "Force Majeure" means an event which is beyond the reasonable control of a Party, is not foreseeable, is unavoidable and not brought about by or at the instance of the Party claiming to be affected by such events and which has caused the non-performance or delay in performance, and which makes a Party's performance of its obligations here under impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other extreme adverse weather conditions, strikes, lockout or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Maieure to prevent), confiscation or any other action by Government agencies.
- Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or by or of such Party's Sub-Consultancy Agencies/Organisations or agents or employees, nor (ii) any event which a diligent Party could reasonably have been expected both to take into account at the time of the conclusion of this Contract, and avoid or overcome in the carrying out of its obligations here under.
- Force Majeure shall not include insufficiency of funds or inability to make any payment required here under.
- 23.2. **No Breach of Contract**: The failure of a Party to fulfil any of its obligations here under shall not be considered to be a breach of, or default under this Contract in so far as such in ability arises from an event of Force Majeure, provided that the Party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms and conditions of this Contract.

23.3. Measures to be Taken:

- A Party affected by an event of Force Majeure shall continue to perform itsobligations under the Contract as far as is reasonably practical, and shall take all reasonable measures to minimize the consequences of any event of Force Majeure.
- A Party affected by an event of Force Majeure shall not if the other Party ofsuch event as soon as possible, and in any case not later than fourteen (14)days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give written notice of therestoration of normal conditions as soon as possible.
- Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during

which such Party was unable to perform such action as a result of Force Majeure.

- During the period of their inability to perform the Services as a result of an event of Force Majeure, the Agencies/Organizations upon instructions by the "Client", shall either demobilize or continue with the Services to the extent possible, in which case the Agencies/Organizations shall continue to be paid proportionately and on prorate basis, under the terms of this Contract.
- 23.4. Suspension: The "Client" may, by written notice of suspension to the Agencies/Organizations suspend all payments to the Agencies/ Organizations here under if the Agencies/Organizations fails to perform any of its obligations under this Contract, including the carrying out of the Services, provided that such notice of suspension (i) shall specify the nature of the failure, and (ii)shall allow the Agencies/Organizations toremedy such failure, if capable of being remedied, within a period notexceeding thirty (30) days after receipt by the Agencies/Organizations of such notice of suspension.

24. Termination

- 24.1. **By the "Client**": The "Client" may terminate this Contract in case of the occurrence of any of the events specified in paragraphs (a) through(i) of this Clause.
 - If the Agencies/Organizations fails to remedy a failure in the performance of its obligations hereunder, as specified in a notice of suspension pursuant to Clause within thirty (30) days of receipt of such notice of suspension or within such further period as the "Client" may have subsequently approved in writing.
 - If the Agencies/Organizations becomes (or, if the Agencies/Organizations consists of more than one entity, if any of its members becomes and which has substantial bearing on providing Services under this contract) insolvent or go into liquidation or receivership whether compulsory or voluntary.
 - If the Agencies/Organizations fails to comply with any final decision reached as a result of arbitration proceedings pursuant to the decision.
 - If the Agencies/Organizations, in the judgment of the "Client", has engaged in corrupt or fraudulent practices in competing for or in executing this Contract.
 - If the Agencies/Organizations submits to the "Client" a false statement which has a material effect on the rights, obligations or interests of the "Client".
 - If the Agencies/Organizations places itself in position of conflict of interest or fails to disclose promptly any conflict of interest to the Client.
 - If the Agencies/Organizations fails to provide the quality services as envisaged under this Contract. The Consultancy Monitoring Committee (CMC) formulated to monitor the progress of the assignment may make

judgment regarding the poor quality of services, the reasons for which shall be recorded in writing. The CMC may decide to give one chance to the Consultancy firm/agency to improve the quality of the services.

- If, as the result of Force Majeure, the Agencies/Organizations is unable to perform a material portion of the Services for a period of not less than sixty (60) days.
- If the "Client", in its sole discretion and for any reason whatsoever, decides to terminate this Contract.
- 24.2. In such an occurrence the "Client" shall give a not less than thirty (30) days written notice of termination to the Agencies/Organizations.
- 24.3. If the Agencies/Organizations fails to perform as envisaged under this Contract the PBG amount will be forfeited & the Agencies/ Organizations will be blacklisted by the Govt. in H & UD Dept. on recommendation from the Jaga Mission.

Annexure –IV Terms of reference

1. Introduction

From a country that lived in its villages, India is gradually acquiring an urban character. This is evident from the fact that the growth rate of urban population at 6% over the last decade has far exceeded that of rural population at 3.4%. In the next 2 decades the urban population is expected to increase from the present 37.8 crores to 60 crores. The latest census data reveals that India's urban growth is taking place in and around 7,935 towns and cities spread across the country.

In comparison to other states of the country, as per 2011 census Odisha is one of the low urbanized states, but is witnessing a high growth rate of urban population. This growth is taking place in peri-urban areas in informal settlements know as slums. There are 2919 slums in Odisha with a population of more than 4.12 million. These settlements often lack basic land tenure rights and access to basic services, such as clean water, sanitation, proper road and drain facilities, electricity and street lighting.

Residents of informal settlements are also at risk of forced evictions without notice or compensation.

Realizing the need to recognize the rights of the informal settlements and the need to confer land titles upon the slum households, the Odisha State Government enacted a landmark legislation, The Odisha Land Rights to Slum Dwellers Act 2017. As per this legislation, the slum dwellers in slums of medium and small cities ((Municipalities and Notified Area Councils (NACs)) became entitled to heritable and mortgageable land rights for residential use. The legislation is the first of its kind in India and marks a major policy shift by the Odisha government, as it seeks to settle slum dwellers on the land they currently occupy - rather than viewing them as 'encroachers'. It also recognizes the significant contribution of slum dwellers to the economy and to future growth by ensuring inclusive development for all residents.

However, the overall goal is not merely just to issue certificates of land rights to slum dwellers. Though a crucial task in itself, the project looks at land rights as an entry point for transforming existing slums into livable habitats. The land rights program was expanded with a mission called Jaga Mission or Odisha Liveable Habitat Mission, to bring about the transformation of existing slums into livable habitats with provision of all essential civic urban infrastructure including roads, drainage, sewage systems, individual household toilets (IHHL), smart LED street lights, 24x7 piped water supply for households, common work sheds, open space development, Play equipment for children, recreational avenues for elderly and all age-groups etc.

From the initiation of this project, slum communities were involved in the project as major stakeholders. Slum Dweller Associations were formed in different slums to participate in the process of planning and decision making. Number of community mobilization activities and capacity building programmes were organized to ensure their participation in the project. Some of them opened their bank accounts and acted as implementing agency for execution of different urban development projects. However, in number of slums these Associations need to be reorganized, their capacity needs to be built continuously for actively participating in the need assessment exercises, planning and monitoring slum upgradation activities. Further, it is also required to strengthen the SDA towards Community Governance, partnering with city administration on various development works and civic participation.

2. Scope of work

The Jaga Mission Activities are being implemented across all 114 urban areas in 30 districts of Odisha covering 2919 slums. At the city level (ULB level) there is a team function for execution of activities under Jaga Mission.

The current scope of work includes for two cities only as part of the piloting phase. The cities are Bhubaneswar and Cuttack. Based on success of the program will be up scaled to other cities.

The representatives of the Resource organizations (RO) need to closely collaborate and act as a part of the team. However, the specific responsibility of RO will be to mobilize the slum communities and activate the Slum Dweller Associations (SDA), develop a system for maintenance of records and provide handholding support for opening of bank accounts, enabling them to function as a grassroots level organization independently. Within two months of on boarding the RO is to organize at least two Large Group and two Focus Group discussion in each slum of the assigned city and form/reorganize the SDA. The representatives of the ROs will be trained thoroughly by the state team on formation of SDAs and points of discussion in the community meetings.

During next two months the ROs will organize at least four rounds of capacity building programmes for the key functionaries of SDAs as per approved training modules. This will enable the SDAs to develop local level plans and participate in urban development initiatives. During this time the RO will facilitate the SDA in participating in Slum upgradation activities and collaborating as Implementing Partner in the field execution, under various initiatives of Central/State Government and other related opportunities. Further, the RO will continue handholding support to the SDAs to prepare documents for slum upgradation activities, interface with different stakeholders and initiate process for slum de-listing. Minutes of all meetings and all processes as per standard operating procedure (SOP) will be documented by the SDA with support from the RO.

In the last two months, RO will organize at least four rounds of capacity building programmes to strengthen the capacities of the SDA towards keeping the SDA functioning (post de-notification of slums) and engaged in activities related SDA administration and welfare of the community, maintenance and management of community assets, build SDA's decision-making and conflict management abilities and continued participation and partnership with the ULBs in the various initiatives of Central/State Government and other related opportunities.

For all above activities the RO is to depute human resources who will continue for this specific work at least for six months. Normally change of human resources will not be allowed. In exception, the new person needs to be thoroughly trained on the issue. The ROs will be responsible for community mobilization, building trust and gain confidence of urban poor in slums and strengthening their Association to take collective actions at the city level.

The specific responsibilities of the RO will be to ensure that the field staffs engaged are fully trained to carryout assigned activities, provide feedback and coaching, and are gifted with a delivery mind set. Besides that, the RO is:

- To procure and retain quality professional staff.
- Provide technical and managerial support to ensure effective implementation of projects in designated cities.
- Report on progress of activities and coordinate closely with the ULB and Jaga Mission in the discharge of the roles and responsibilities as per agreed terms.

4. Reporting and documentation

Inception report: ROs are expected to submit an inception report within 15 days of getting the assignment. Inception report must include analysis of the situation (existing slums, number of SDAs, status of bank account and capacity building needs), details of RO staff structures, work Plan- including a) an activity schedule b) a training plan containing number of batches, participants, training calendar. The inception report should also include the strategy/ activities to achieve the milestones outlined in the scope of work. The work plan has to be developed in consultation with concerned ULB Jaga Team.

Monthly reports in the agreed format need to be shared by ROs with respective ULB

and Jaga Mission. Jaga Mission and ULB jointly will monitor the progress of programme implementation and interact with the agency to ensure that the program falls within the schedules and agreed timeline.

Final Report on the support including formation, hand holding support to slum communities and SDA, capacity building and slum upgradation need to be submitted by 6th month of engagement.

5. Performance Assessment:

Fortnight performance assessment will be conducted to evaluate achievement obtained by ROs to the desired objective and scope of the work. The evaluation will include the progress vs timeline, quality of training and capacity building, innovation and scale of impact, along with other related deliverables.

The allotment of SDAs to ROs (mapping) will be provisional, ideally mapped in a contiguous manner (geographically) and allotment will be revised (increased or decreased) subject to performance assessment.

Feedback on performance will be provided to the ROs. In case of performance at a scale of average or below average, for more than two consecutive appraisal periods, the Consultancy Monitoring Committee (CMC) may notify on de-scoping to the RO as per the terms of the contract.

In case of performance at a scale of high or outstanding, throughout the period of engagement, the Consultancy Monitoring Committee (CMC) may extend the RO the scope for empanelment for additional cities.

6. Eligibility of Resource Organizations:

Strengthening of the capacities of Slum Dwellers Associations (SDAs) through a process of capacity building, resource mobilization, skill enhancement etc. is the key to empower and mainstream slums into the city lifeline (through their upgradation and transformation) and making SDAs, an integral part of the city development, across 114 ULBs in Odisha. In this connection it is important to mention here that 2,919 SDAs have already been formed and promoted for active participation. Now the time has come to further mobilize, activate and strengthen all the 2919 SDAs of the state, through inputs and support, so that it leads to the emergence of active and empowered associations that can work towards the welfare of their community on one hand and partner with the Government towards enhancing the civic strength of the cities. In this light, Jaga Mission, Housing and Urban Development, Govt of Odisha has decided to open up a bidding process for selection of Resource Organizations and a brief of their eligibility criteria is given as Annexure V:

Annexure –V Bidders Eligibility Criteria

The Organization must have the following credentials:

- Must be registered non-profit Civil Society Organizations (CSO) set up by state or central governments relevant act.
- RO must be registered in NGO Darpan Portal & must have UID number from NITI Ayoga.
- Must have prior experience in social mobilization, training and capacity building in rural & urban areas.
- Should have minimum experience of 7 years in social mobilization and capacity building through community driven programmes
- -
- The organization should have worked with Govt/Semi Govt organization in the area of Urban poor, Community strengthening, Training, Capacity Building.
- Must have a turnover of minimum of Rs 50 Lakhs per Annum during the last three financial years (for applying for one city) and Rs 100 lakhs for more than one city.
- Must have a minimum of 20 experienced manpower. (For applying for one city) (as on 31.03.2021) and 40 for more than one city who are effective in guiding people to take up various Capacity building programs. The qualification and experience for the employee (Capacity Building professional) is outlined as:
- v. Masters in Social Work/ Masters in Arts/ Masters in Business Administration/Law.
- vi. Minimum of 5 years of experience in Community Mobilization, Capacity Building trainings.
