In exercise of powers enshrined under Rule-79 of Orissa Municipal Employees(Pension) Rules,1989, Government have been pleased to confer the Commissioners of Municipal Corporations of the State the power of Pension Sanctioning Authority in respect of retired employees of respective Municipal Corporations. Pension shall be sanctioned after due verification by the District Local Fund Audit and the Pension Sanctioning Authorities shall have to be meticulous and responsible while sanctioning the final pension at their level to ward off any possible discrepancies. The pension forms may be modified suitably at the Corporation level as per requirement.

Commissioner, Bhubaneswar Municipal Corporation is conferred with the power of Pension Sanctioning Authority in respect of retired employees of Odisha State Municipal Council Union, Bhubaneswar.
