RESOLUTION

Sub: Payment of quantum of additional Pension/Family Pension of the basic pension on completion of 80 years of age with similarly situated State Govt. Employees.

The Pension / Family Pension / T.I. & Gratuity for the pensioners of the Urban Local Bodies of the State and Odisha State Municipal Council Union has been revised in H. & U.D. Department Resolution No. 1414/HUD, dated 16.01.2020 as per revised scale of pay 2017 w.e.f .01.01.2016.

2. Representations have been received from different retired employees associations and retired employees from different ULBs for sanction of quantum of additional pension/family pension of the basic pension on completion of 80 years of age at par with similarly situated State Govt. Employees.
3. After careful consideration of the matter, the State Govt. in H & UD Department have been pleased to accept the recommendation for additional quantum of pension on attaining the age 80 years and above.

(a) The quantum of additional pension/family pension would be made available to the old pensioners/family pensioners from the date of publication in the Gazette are indicated as below:-

Age of pensioners/family pensioner	Additional quantum of Pension
From 80years to less than 85 years	20% of revised basic pension
From 85years to less than 90 years	30% of revised basic pension
From 90years to less than 95 years	40% of revised basic pension
From 95years to less than 100 years	50% of revised basic pension
100 years or more	100% of revised basic pension

4. The Pension Sanctioning Authorities should ensure that the date of birth and the age of a pensioner/family pensioner to facilitate the payment of additional pension by the pension disbursing authority as soon as it becomes due.
5. The amount of additional pension shall be shown distinctly while giving the pension/family pension. For example ,in case where a pensioner is more than 80 years

of age and his pension is Rs.10,000pm,the pension shall be shown as(i)Basic pension=Rs.10,000/- and(ii) Additional pension=Rs2,000 pm. The pension on his attaining the age of 85 years shall be shown as(i) Basic pension=Rs.10,000/- and (ii)additional pension=Rs.3,000 p.m.

6. All other provisions issued in Housing & Urban Development Department Resolution No.1414/HUD,dtd.16.01.2020 are remain unchanged.

Ordered that the Resolution be published in an Extraordinary issue of the Odisha Gazette and forwarded to all Departments of Government / Heads of Department / RDCs / Dist. Magistrates / All Municipal Corporations/All Municipalities/All Notified Area Councils/Odisha State Municipal Council Union.
