### NOTIFICATION

The 19th August, 2021

**S.R.O NO.285/2021**— Whereas, the draft of certain rules to amend the Urban Local Bodies (Rehabilitation Assistance) Rules, 2018 was published as required by Section 22 read with Section 18 of the Odisha Municipal Services Act, 2015 (Odisha Act. 7 of 2016) in the Extraordinary issue No. 937, dated the 25th June , 2021 of the *Odisha Gazette* under the notification of the Government of Odisha in the Housing & Urban Development Department No. 8836-HUD-MUN-ADM-16/2019/HUD., dated the 28th April, 2021 inviting objections and suggestions from all persons likely to be affected thereby, on or before the dated 28th May, 2021 ;

And, whereas, no objection or suggestion has been received in respect of the said draft within the date specified;

Now, therefore, in exercise of the powers conferred by Section 22 read with Section 18 of the Odisha Municipal Services Act. , 2016, the State Government do hereby make the following rules to regulate recruitment to amend the Urban Local Bodies (Rehabilitation Assistance) Rules, 2018, namely:—

**1. Short Title and Commencement:** - (1) These rules may be called the Urban Local Bodies (Rehabilitation Assistance) Amendment Rules, 2021.

(2) They shall come into force. on the date of their publication in the *Odisha Gazette*.

**2.** In the Urban Local Bodies (Rehabilitation Assistance) Rules, 2018, for rule 3, the following rule shall be substituted, namely:-

"3. Application of the rules applicable to the Government Employee :— The provisions of the O.C.S. (Rehabilitation Assistance) Rules, 2020 as amended, from time to time, shall, *mutatis and mutandis*, be applicable to a member of the family of the

employees of the Urban Local Bodies who dies while in service with the following modification, namely:—

Sub-rule (3) of rule 6 of the O.C.S. (Rehabilitation Assistance) Rules, 2020 in its application to Urban Local Bodies shall be read as follows:-

"In the event the applicant meets the standard as per the criteria outlined under rule 6(2) of the O.C.S. (Rehabilitation Assistance) Rules, 2018 the Appointing Authority shall appoint the applicant in a suitable available base level Group-D vacant post under his control, but if the vacancy is not available in the concerned Urban Local Body, where the deceased was serving at the time of his/her death the appointment of applicant may be made in nearby Urban Local Body considering the vacant Group-'D' post in that Urban Local Body and the Director, Municipal Administration may intimate the concerned Urban Local Body to issue necessary appointment order in favour of the candidate in Group-'D' post and the financial burden due to such appointment shall be borne by the concerned Urban Local Body only'."
