**Notification**

The state of Odisha has been witnessing rapid spatio-temporal changes on account of unplanned and unsystematic growth of the peri-urban and expanding rural areas, which is posing a serious challenge for the city managers and city planners when these areas are either getting included in existing urban areas or new townships are carved out of these areas. In the absence of any policy to regulate the growth of such areas, creation of infrastructure and provision of services often suffer setbacks. Apart from that, the decision of converting rural areas in to urban also encounter resistance from inhabitants and other pressure groups who apprehend stricter regimes of building plan approvals and enhanced cost of services.

In order to obviate such bottlenecks which impede proper urbanisation, the Government has been pleased to notify the "Rural Urban Transition Policy" vide Gazette Notification Number 1671 dated 10.07.2023 and envisaged a number of progressive measures to ensure smooth transition of the rural areas in to townships with necessary infrastructure and services.

In the process of implementation of the policy, there will be necessity of taking several decisions which will impact multiple sectors in terms of execution of work, provision of funds and delivery of services. Since this will involve establishment of new systems and institutions, constitution of multi-sectoral bodies will be critical to the successful implementation of the policy. It is in this context, that the policy envisages constitution of high level committees for expeditious decision making and execution.

In consonance with the provisions of the policy, the Government has been pleased to constitute the Steering Committee and Advisory Committee with the following members to effectively implement the Rural Urban Transition Policy in a systematic and time bound manner, while ensuring coordination with all the stakeholders.


