RESOLUTION

No. 13-48-110/2017 18301 /HUD, Bhubaneswar, Dated the 10.8.17

Sub: *Revision of Pension/ Family Pension/ T.I. and Gratuity of the Retired Employees of the Municipal Corporations, Municipalities, Notified Area Councils and Odisha State Municipal Council Union as per Revised Pay Scales of 2008 with effect from 01.01.2006.*

Consequent upon revision of scales of pay of Corporations, Municipalities, Notified Area Councils vide Resolution No.5000/HUD Dated 28.02.2009 and Resolution No.5004/HUD Dated 28.02.2009 respectively; the State Government revised the Pension/ Family Pension/ T.I. and Gratuity of the Retired Employees of the Municipal Corporations, Municipalities and Notified Area Councils etc. with effect from 01.01.2006 in H&UD Department Resolution No.15330/HUD Dated 01.08.2014 and Resolution No.15334/HUD Dated 01.08.2014 respectively. Government enhanced the maximum limit of Death-cum-Retirement Gratuity from Rs.1.50 lakhs to Rs.4.00lakhs and restoration period with effect from 01.12.2008 for the retired employees of ULBs.

2. Government received representations from different Retired Employees Association of different ULBs against the aforesaid decision with prayer to extend the benefits of enhancement of limit of Death-cum-Retirement Gratuity and adoption of new method with effect from 01.01.2006 instead of 01.12.2008. The Retired Employees Association of different ULBs have also demanded for modification of formula adopted for calculation pension for Pre-2006 Pensioners at para No. 7 of Housing & Urban Development Department Resolution No. 15330 and Resolution No. 15334 Dated 01.08.2014 respectively.

3. After careful consideration, the Government in H & UD Department have been pleased to modify the Resolution on partially as follows:-

- a) The provisions of para 2 of H & UD Department Resolution No.15330 and Resolution No.15334 dated 01.08.2014 stands modified and the employees who have retired during the period from 01.01.2006 to 30.11.2008 are entitled to DCRG up to a maximum of Rs.4.00 lakhs on revision of their pay scales w.e.f.01.01.2006.
- b) The fitment formulas laid down in para-7 for pre-2006 pensioners may be made as follows;
- i) Existing Pension/Family pension by multiplying existing basic pension/basic family pension by a factor 1.86.
- ii) Fitment weightage of 40% of the existing basic pension/basic family pension.
- iii) The amount so arrived at, shall be regarded as consolidated pension/family pension w.e.f. 01.01.2006.

- iv) Consolidated pension/ family pension so arrived involving fraction of a rupee shall be rounded off to the next higher rupee.

- c) The maximum limit mentioned in para 4(a)(c) and Para-7 of H&UD Department Resolution No.15330 & No.15334 Dated 01.08.2014 may be substituted as pension/family pension for pre-2006 may be limited to maximum Rs.10,000/-P.M plus T.I as admissible from time to time.
- 4) All other provisions issued in Housing & Urban Development Department Resolution No.15330/HUD Dated 01.08.2014 and Resolution No.15334/HUD Dated 01.08.2014 are remain unchanged.

This has been concurred by the Finance Department vide UOR No.3408/ACSF, Dated 14.07.2015 and under consultation with Law Department vide UOR No.303/L, Dated 03.02.2016.

ORDER:- Ordered that the Resolution be published in the next issue of the Odisha Gazette and forwarded to all Departments of Government/ Heads of Department/ RDCs/ District Magistrates/ All Municipal Corporations/ All Municipalities/ All Notified Area Councils/ Odisha State Municipal Council Union.
