

HUD-WS-SCH-0109-2019/ 6006 /HUD, Bhubaneswar, In order to encourage the Jalsathis to improve their performance and further strengthen the community partnership model, the incentive framework for Jal Sathis is modified as follows:

- i. For water bill payment collection: The incentive for revenue collection under water supply sources is **enhanced** from 5% of revenue collected to **7.5%** (through MPoS machine) of revenue collected.
- ii. Water Quality Tests at Consumer Taps: Numbers of water quality tests by Jalsathi is hereby **increased from 20 to 100 pair of water quality tests (H2S/ FRC) per month** thereby enhancing the incentive from Rs.200/- per month to Rs.1000/- per month (maximum)


This enhancement will be effective from **1<sup>st</sup> April 2024**.


