This is an appeal petition file u/s 91 (2) of the ODA Act, 1982 by Subhranshu Sekhar Mishra, S/o Late Udayanath Mishra, M-93, Baramunda Housing Board Colony, Khandagiri, Bhubaneswar challenging the order dated 07.03.2006 passed by the Secretary, BDA in UAP Case No. 520/05.

Heard the Parties.

The allegation against the appellant is that, he has undertaken unauthorised construction of RCC Roofed house and ACC Roofed House beyond the allotted Scheme House/ Plot No. M-93 in Mauza-Baramunda in Baramunda Housing Board colony.

During course of hearing, after careful consideration of the submissions made by both the parties, this court observed the appellant has violated the norms as enshrined under the building plan issued in his favour and erected unauthorized structure beyond approved plan. Finding no merit in the appeal of the petitioner, this court uphold the orders of the lower court and directs BDA to act accordingly within the purview of law.

Accordingly, the appeal petition is disposed off.
