The case record is put up today.

Both the parties are present.

This is an appeal petition file u/s 91 of the ODA Act, 1982 by the Appellant Trinath Patra, President of Kalinga Baishya Sangha, Plot No.-624/B, Road-10, Aerodrum Area, Bhubaneswar challenging the UAP No. 500/2005.

Heard the Parties.

The allegation against the appellant is that, the appellant has undertaken unauthorised construction of RCC Roofed structures on revenue Plot No. 20 (pt), Sub Plot No. 83 and 84 in Mouza - Mahabhoi Sasan, Bhubaneswar.

During course of hearing, after careful consideration of the submissions made by both the parties, this court observed the appellant has violated the norms as enshrined under the building plan issued in her favour and erected unauthorized structure beyond approved plan. Finding no merit in the appeal of the petitioner, this court upholds the orders of the lower court and directs BDA to act accordingly within the purview of law.

Accordingly, the appeal petition is disposed of.
