This memorandum of appeal has been filed under section -2 of section 91 of ODA Act,1982 by Sri Sibaram Sahu -vrs- BDA, Bhubaneswar challenging the Order dated 12.09.2017 by OSD, BDA, Bhubaneswar.

The allegation against the appellant is that he has undertaken unauthorized construction of G+2 storied residential building over the Plot No. 187/882/1317, Sub-plot No. 58, Khata No.345/369, Mouza- Ebarang, Bhubaneswar.

During the course of hearing the appellant submitted the approved building plans & drawings which has already been regularized by BDA under "scheme for regularization of unauthorized construction,2019" vide BDA letter No. 443044 dtd. 23.12.2021.

Considering the facts and circumstances made above and materials on record, BDA is directed to examine the status of regularization of unauthorized construction made by the appellant and act upon the order accordingly.

Hence this appeal disposed of.
