None appeared for the appellant, the representative of Bhubaneswar Development Authority (BDA), Bhubaneswar [Respondent] is present.

This Memorandum of Appeal dated 16.04.2008 has been filed by Sri L.Nitimanjari Reddy (aged about 34 years) W/o Late L. Kailash Reddy, resident of House No. LIG-117/20, Chandrasekharpur Housing Scheme, PH-II (OSHB), Mz-Chandrasekharpur, Bhubaneswar, Dist- Khurdha under sub-section (2) of Section- 91 of the Odisha Development Authorities Act, 1982, [here in after referred to as "the Act"] registered as TP Appeal No.40/2008.

Heard the Parties.

The appellant filed the instant to set aside the impugned order in UAP No. 53 of 2008 and communicated to the appellant vide letter No. 1278/Enf./BDA, Dt. 10.04.2008 for removal of the unauthorized/deviated construction undertaken by the appellant.

The allegation against the appellant is that, the alleged unauthorized additional construction of G+1 storied RCC roofed house undertaken on encroachment of adjacent Government land to the existing scheme House Bearing No. LIG-117/20 under Chandrasekharpur Housing Scheme, PH-II(OSHB) in Mz--Chandrasekharpur, Bhubaneswar, beyond the allotted scheme house.

Perused the memorandum of appeal of the appellant, wherein he has conceded with the aforesaid allegation.

Considering the facts and submission made by both the parties , this court is of view that, the said construction erected by the appellant is deviating the Planning and Building Standard Regulation of ODA Act, 1982 and found to be unauthorizedly constructed by way of encroaching adjacent Government land. Hence this court is not inclined to interfere with the order passed by the lower court.

Accordingly appeal is disallowed.
