**NOTIFICATION**

Whereas a proposal containing the intention of the Governor of Odisha to specify the whole of the Polasara Notified Area Council in the district of Ganjam as a "Smaller Urban Area" was published, as required under sub-section (2) of section 4 of the Odisha Municipal Act, 1950 (Odisha Act, 23 of 1950) in the Extraordinary issue of the Odisha Gazette No. 5978, dated the 22<sup>nd</sup> December, 2025 under Notification No. 31266, dated the 22<sup>nd</sup> December, 2025 of the Government of Odisha in the Housing & Urban Development Department, inviting objections and suggestions thereon;

And whereas, no objection or suggestion was received within the stipulated period;

And whereas the draft notification issued in this behalf and published in the Official Gazette has been duly considered and is hereby confirmed;

Now, therefore, in exercise of the powers conferred by clause (2) of article 243-Q of the Constitution of India, read with sub-section (2) of section 4 of the said Act, and having regard to the population of the area, the density of population, the revenue generated for the local administration, the percentage of employment in non-agricultural activities and the economic importance of the area, the Governor of Odisha hereby specifies the local area comprising the whole of the Polasara Notified Area Council in the district of Ganjam with the boundaries described in the Schedule appended hereto, as a "Smaller Urban Area".


