

NOTIFICATION

In exercise of the power conferred by clause (2) of the Article, 243-Q of the Constitution of India, read with sub-section (2) of section 4 of the Odisha Municipal Act, 1950 (Odisha Act, 23 of 1950), the Governor of Odisha, having regard to the population of the area, the density of the population, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance of the area, intends to specify whole of the Bhanjanagar Notified Area Council area in the district of Ganjam as a "Smaller Urban Area".

Objections and suggestions in writing are invited from all persons of the aforesaid area who are likely to be affected thereby within a period of 30 days from the date of publication of this notification in the Odisha Gazette and objections and suggestions, if any, which will be received through the Collector and District Magistrate, Ganjam within the said period shall be duly considered by the State Government.
